Business of the Year

- Nomination must be submitted by December 1 of the calendar year.
- Nominee must be an active business operating in Power County.
- Nominee must be an AF Chamber Member in good standing.
- Nominee must demonstrate economic support of the Greater AF Business community:
 - Growth through creation of jobs
 - Provides exemplary customer service
 - Volunteers in the Greater AF Community
 - Supports the AF Chamber
- The Chamber reserves the right to request two letters of reference from a third party. The nominee may furnish one of these letters if they did not submit the original form.

Newby Award – New Business Award

- Nomination must be submitted by December 1 of the calendar year.
- Nominee must be an active business or Non-Profit operating in Power County for *less than 5 years*.
- Nominee must be an AF Chamber Member in good standing.
- Nominee must demonstrate economic support of the Greater AF Business community:
 - Growth through creation of jobs
 - Provides exemplary customer service
 - Volunteers in the Greater AF Community
 - Supports the AF Chamber
- The Chamber reserves the right to request two letters of reference from a third party. The nominee may furnish one of these letters if they did not submit the original form.

The Heart Award - NON-Profit Award

- Nomination must be submitted by December 1 of the calendar year.
- Nominee must be recognized as a Non-Profit operating in Power County.
- Nominee must be an AF Chamber Member in good standing.
- Nominee must have shown exemplary support to the Greater AF Area through contributions and support of the community while adhering to the non-profit's mission statement.
- Mission statement of the non-profit organization must be provided.
- The Chamber reserves the right to request two letters of reference from a third party. The nominee may furnish one of these letters if they did not submit the original nomination form.

Volunteer of the Year Award

- Nomination must be submitted by December 1 of the calendar year.
- Demonstrate and promote a successful idea or service work and volunteerism that benefits Power County.
- Does not have to be a Chamber Member.
- Current or past AF Chamber Board members may be eligible.
- Chamber reserves the right to request one letter of reference from a third party.

Award NOMINEES will receive:

- Company name listed on the Chamber website.
- Company name and description in Business Awards Program.
- Free ticket to the Awards Banquet & Reception.

Award WINNERS will receive:

- Name listed as Award winner on the Chamber's website, PR, and promo materials.
- On-going recognition throughout the year at various Chamber events.
- Recognition during the Awards Banquet and Reception.
- Free tickets to the Awards Banquet and Reception.
- Special award engraved with name at the Awards Banquet and Reception.
- Grand Marshall Entry in the annual American Falls Day Parade – banner provided.
